

Patient Care Technician Certification: Promoting the Technical Expertise of Your PCTs to Improve Patient Care in a Technological World

INTRODUCTION

In the dialysis facility the nurse, physician, dietitian, social worker and PCT collaborate to provide patient care. It is the responsibility of the nurse to assess PCT knowledge and skill competency prior to the delegation of dialysis-specific tasks.

The Conditions for Coverage mandate that all PCTs were to be certified by April 15, 2010. In addition, the American Nephrology Nurses Association (ANNA) has a position statement in collaboration with the National Association of Nephrology Technicians (NANT) to support and encourage technicians to become certified.

In a large dialysis organization, ensuring that all PCTs obtain certification before the deadline is challenging.

METHODOLOGY

- Obstacles include direct communication to PCTs, test preparation and a limited number of certification test dates prior to on-line testing.
- To address these challenges, DaVita created a work group to implement a training program for PCT teammates.
- Posters were developed and distributed every two weeks via internal communication channels.
- Offered bridge loans, study materials, and electronic practice exams.


FA's, What Are Your Responsibilities with PCT Certification?

183 bays until CHS Technician Certification: April 15, 2010

1. Talk to each of your technicians; make sure they have an application filled out or an exam date set
2. You must review the application for accuracy prior to signing
3. High school diplomas must match the last name of the applicant. Or they must include legal documents for name differences is an marriage certificate
4. Help them with the Bridgie Loan application and send the fee with the application
5. Make copies of the applications for the technician
6. Please include a signed reference letter if required
7. Encourage and help them prepare to take the exam
8. Celebrate when they pass the exam
9. Notify your point preson to enter them into People Soft as soon as they receive the letter of passing- Do Not Walt for the Certification card to report them as certified
10. If they have not heard from the examining agency- keep calling and leaving missages until you hear if they have passed
11. If the tearmate refuses to become certified, remind them that they will no inonger be able to work in dialysts as a technician until certified




3. Guidelines for submitting complete application

TEAM APPROACH

- Team approach used to encourage study and review through:
- Study groups
- Social workers involved in helping to overcome test anxiety
- Physicians and Nurses testing PCT knowledge by providing informal "pop questions" throughout the shift

RESULTS

To date, nearly 7000 PCTs have taken the practice exam.




Figure 1. Percent of PCTs certified

CONCLUSIONS

- Since the beginning of 2009, we have improved communication to PCTs about the certification and provided a number of preparation options, including:
- a classroom-training program lead by a Clinical Services Specialist,
- a study guide to prepare the PCT for the exam,
- an interactive, online learning module, and
- a practice exam to test knowledge.
- The percentage of PCT certified increased:
- 23% within 6 months after the training program began and
- 67% over the first year. (Figure 1)

KEY LEARNINGS

✓ Through these efforts, our PCTs have become certified prior to the deadline, satisfying requirements and earning the confidence of patients, nurses and physicians.
